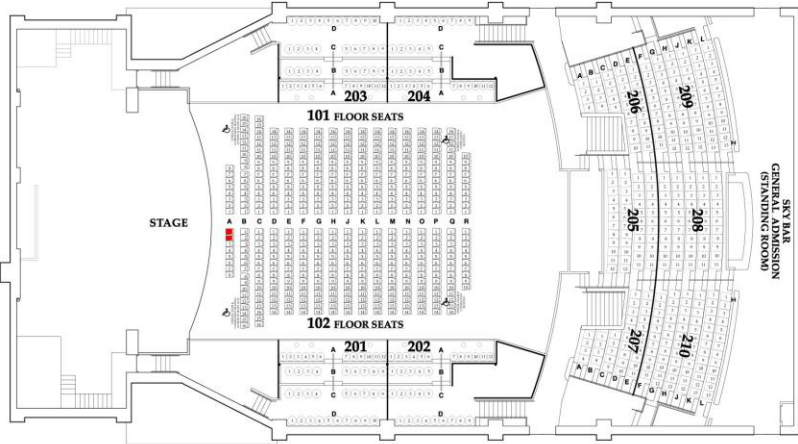
12. Privacy
